

RIGHT-OF-WAY VACATION DESCRIPTION

A PARCEL OF LAND SITUATED IN THE NORTHWEST QUARTER OF SECTION 19, TOWNSHIP 4 SOUTH, RANGE 65 WEST OF THE 6th PRINCIPAL MERIDIAN, AND THE NORTHEAST QUARTER OF SECTION 24, TOWNSHIP 4 SOUTH, RANGE 66 WEST OF THE 6th PRINCIPAL MERIDIAN; CITY OF AURORA, COUNTY OF ARAPAHOE, STATE OF COLORADO; BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHWEST CORNER OF SAID SECTION 19, FROM WHICH THE WEST QUARTER CORNER OF SAID SECTION 19 BEARS SOUTH 00°14'25" EAST, A DISTANCE OF 2,643.97 FEET, WITH ALL BEARINGS HEREIN RELATIVE THERETO;

THENCE SOUTH 04°43'12" EAST, A DISTANCE OF 384.08 FEET TO THE **POINT OF BEGINNING**, BEING A POINT ON THE EASTERLY RIGHT-OF-WAY OF GUN CLUB ROAD AS DESCRIBED IN THE DOCUMENT RECORDED UNDER RECEPTION NUMBER B3167939 IN THE RECORDS OF THE ARAPAHOE COUNTY CLERK AND RECORDER;

THENCE SOUTH 00°14'25" EAST, A DISTANCE OF 464.08 FEET TO A POINT ON THE EASTERLY RIGHT-OF-WAY OF EAST LOUISIANA PARKWAY AS DESCRIBED IN SAID DOCUMENT RECORDED UNDER RECEPTION NUMBER B3167939, BEING THE BEGINNING OF A NON-TANGENT CURVE CONCAVE SOUTHWESTERLY HAVING A RADIUS OF 529.97 FEET, THE RADIUS POINT OF SAID CURVE BEARS SOUTH 59°57'54" WEST;

THENCE NORTHWESTERLY ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF 11°12'54", AN ARC LENGTH OF 103.74 FEET;

THENCE NORTH 00°14'25" WEST, A DISTANCE OF 194.05 FEET TO A POINT ON SAID EASTERLY RIGHT-OF-WAY OF GUN CLUB ROAD, BEING THE BEGINNING OF A NON-TANGENT CURVE CONCAVE WESTERLY HAVING A RADIUS OF 1,045.00 FEET, THE RADIUS POINT OF SAID CURVE BEARS NORTH 66°58'16" WEST;

THENCE NORTHERLY ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF 10°42'40", AN ARC LENGTH OF 195.36 FEET TO THE **POINT OF BEGINNING**.

CONTAINING AN AREA OF 0.436 ACRES, (18,975 SQUARE FEET), MORE OR LESS.

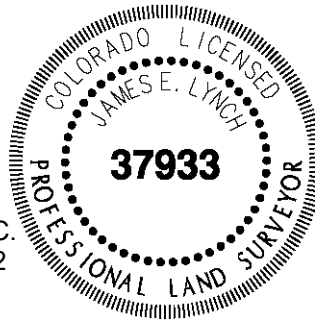

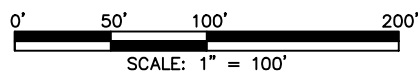
