6. Civil Engineering

6A. The site plan amendment will not be approved until the preliminary drainage letter/report is approved.

Response: Acknowledged. Civil CDs have been submitted and are in the review process.

6B. Include site plan notes and see public works comment to add additional note.

Response: New sheet added with site plan notes (GN-1, 03 of 14). Includes requested note as item #29.

11. Forestry (Rebecca Lamphear / 303-739-7139 / rlamphea@auroragov.org / Comments in purple)

7A. Several of the trees will be relocated, update notes regarding watering. For every inch caliper of tree 10 gallons of water will be required. As an example, a 2" caliper tree will require 20 gallons of water with the regime listed under transplanted trees, note 7.2. Also include a note regarding periodic inspection of spaded trees and soil, water as needed outside of the above listed schedule.

Response: Revisions made. Added notes 7.3 and 7.4.

7B. Add Tree #8 and #9 back in existing tree identification table.

Response: Renumbered trees in table (and corresponding trees on this plan sheet and landscape plan sheet) to be sequential, eliminating numbers not used.

7C. Three trees will require mitigation. If trees will be planted on the site, please show a symbol indicating trees that are specific to tree mitigation. Use the mitigation table listed below on your Tree Protection Plan P. L2-1.

The caliper inches that will be lost are 18", but only 5" would be required for planting back onto the site. The mitigation value is \$550.00.

Response: Many trees will be planted on site, with 11 trees specifically identified as tree mitigation. The trees are identified on the Landscape Plan with an asterisk (*) symbol. Mitigation Tree Table has been updated on this sheet with a note indicating this.

The Tree Mitigation Table has been replaced. Note: tree numbers have been updated per table revision due to comment 7B above.
