### PLANNING DEPARTMENT COMMENTS

## 1A. Community Questions, Comments and Concerns

1A. Please respond in your resubmittal to the major issues identified in the following citizen comments: **Lynn Reynolds**- I want to thank you for your assistance with this issue, and for recognizing that very few of the Tollgate Crossing residents understand or are on board with the way in which Mr. Holshier and Xcel as a whole have discounted our concerns, wishes, or requests. I was at the forefront of the effort to ask for concessions from the beginning, over a year and a half ago. I have attended City Council meetings, Xcel meetings, HOA meetings, and other special meetings, yet, I did not receive notice of the request for comments regarding the upcoming City Council decision, and missed the deadline for response on 8/24. There have been no signs placed.

We spoke to Mr. Holshier about having the silver poles instead of the brown weathered poles, and he agreed. He advised us that there is absolutely no cost difference for either pole. In his presentation to the County to receive approval to begin the substation on the 1.5 miles of property, he made several statements that were not based in fact, including embellishment regarding the number of meetings he had held with us.

We are extremely concerned with the lack of formal testing with regard to health risks and EMF exposure, especially with regard to children. Double poles will be running through Tollgate neighborhoods, in children's parks and within a few hundred feet of an elementary school. The poles already there are very old. Other, more aesthetic and safer methods for conducting electricity could be utilized in populated areas. Thank you for anything you can do to help us to achieve some concessions, Mr. Rodriguez. You are the first, and only, individual who has listened to our concerns since this project began. We very much appreciate anything you can do. Thank you again.

### 2. Zoning and Land Use Comments

2A. Previous comment: Staff received input in the past regarding the color of the transmission line poles. The photo simulations and show both galvanized poles and self-weathering poles that appear to be a *Rustic* shade of brown. Both are shown to be utilized in the 3.9 mile long segment within the city. Please clarify for staff if Xcel Energy has had discussions in the past regarding the preference of the residents regarding the color of the poles, and if so, if it is reflected in the plans.

2B. Previous comment: Identify what mitigation or compensation was provided to and for adjacent or affected property owners in other jurisdictions. For example was any compensation provided for increasing landscaping/screening along the perimeter of a property line to help mitigate visual or aesthetic impacts? If this was provided, is any planned for affected property owners that live along this proposed expansion? Please clarify for staff.
