- 5A. Add the following to the Site Plan Amendment. See the staff redlined plan (item 2A).
- The original site plan must reflect the proposed work. Show and label the changes to the plan.
 - Make sure to provide clouds and deltas describing the proposed changes.
 - Make sure to include any references that address requirements, such as distances from buildings and combustible construction to ensure appropriate separation distances.
 - Please include the mentioned corrections on the construction documents.
 - If any impact protection is proposed, please identify and label the impact protection that will be provided. For example: enclosure or bollards around facilities.

6. Aurora Water (Casey Ballard / 303-739-7382 / cballard@auroragov.org / Comments in red)

- 6A. Call out the owner of wet utilities and dimension the distance between the outside of the pipe to the outside of the proposed foundation.
- 6B. Adjust to include the wet utility to the west. Include the owner and distance between the outside of the pipe and the outside of the proposed foundation.
