First Technical Review

PLANNING DEPARTMENT COMMENTS

1. Landscaping Issues (Kelly Bish / 303-739-7189 / kbish@auroragov.org / Comments in bright teal)

- 1A. Update the Legend to include WM and wood mulch.
- 1B. According to the plant schedule, the same tree is being specified but with different tree symbology and with a different plant call out, but it appears to be the same tree. Please correct the plant schedule and please pick a tree symbol.
- 1C. Why is Autumn Blaze Maple listed twice in the Plant Schedule?
- 1D. Update note five on Sheet 22 to reflect the language of notes one, two, and three under Installation and Maintenance, page 13.
- 1E. Artemisia is a perennial and not a shrub. Please move it to a perennial category in the Plant Schedule. Perennials can be used in the curbside landscape, but may not be more than 5% of the total shrub count within a designated curbside landscape i.e. 48th to 50th or 50th to 52nd, etc. These are typically one-gallon so to meet code requirements, there would need to be three one-gallon perennials to one shrub.
- 1F. Provide the specific native seed mix.
- 1G. Update the Plant Tabulations table and the plan to reflect the use of the Artemisia plant. See comment on this sheet.

- 2A. Modify striping per the comments on the redlines.

- 3A. Review layers and colors and make the infrastructure the top layer so that it can be seen.
- 3B. The new layer showing the asphalt is the same color as the existing utility infrastructure, making it impossible to see the existing utilities.
- 3C. The hydrant lateral was updated but the stub call out was not. Please ensure that the lateral remains the same size for the entire length.
