

**AUTHORIZATION OF OWNER**

**ASPEN BUSINESS PARK**

**EAST YALE AVENUE AND SOUTH GUN CLUB ROAD**

THIS AUTHORIZATION OF OWNER (this "Authorization") is made this \_\_\_\_\_ day of January, 2022 (the "Effective Date"), by GEORGE HOFFMAN and GUN CLUB ROAD REAL ESTATE PROGRAM, LLLP (collectively, the "Owner"), in favor of ABP 470 LLC, a Colorado limited liability company, and its assignees (the "Applicant"), and Applicant's agents, including, but not limited to, GREY WOLF ARCHITECTURE, WARE MALCOMB and WHITE BEAR ANKELE TANAKA & WALDRON (collectively, the "Agents").

**RECITALS**

A. Owner owns certain real property legally described on Exhibit A attached hereto (the "Property").

B. Owner and Applicant are parties to that certain Contract to Buy and Sell Real Estate dated September 13, 2021 (as amended, the "Contract") for the purchase and sale of the Property.

C. Owner would like to memorialize its authorization of Applicant and its Agents to submit various land development applications and related documents to the City of Aurora, Colorado (the "City") that relate to the development of the Property.

**AUTHORIZATION**

**1. Authorization.** Owner hereby authorizes Applicant and its Agents to submit, on Owner's behalf, all applications and related fees necessary to obtain approval by City for certain approvals and entitlements for the development of the Property including, but not limited to, a Master Plan, a Site Plan, a Preliminary Plat, a Subdivision Plat and a Service Plan for Metropolitan District (collectively, the "Entitlement Approvals").

Owner further authorizes Applicant and Agents to act on its behalf with regard to any actions Applicant and its Agents deem necessary to obtain the Entitlement Approvals, including, but not limited to, authorization to submit and amend all applications and supporting documents required by City in connection with the Entitlement Approvals (collectively, the "Application"), to meet with and appear before City and its representatives and agents to discuss the Application, to obtain City's approval of the Application, and to take any and all additional actions Applicant and its Agents deem reasonably necessary to obtain City's approval of the Application; *provided, however*, that none of the Entitlement Approvals shall be recorded against the Property without Owner's approval or upon Applicant demonstrating to City that Applicant has obtained fee title to the Property.

**2. Term of Authorization.** Owner's authorizations granted in this Authorization shall be effective from the Effective Date to Owner's notice to City that the Contract has been terminated.

**3. Counterparts.** This Authorization may be executed in counterparts, each of which shall be deemed an original and all of which, when taken together, shall constitute one and the same instrument. The parties agree to accept digitized copies of manual signatures or other electronic signatures on this Authorization.


