Your estimated Administrative Decision date is now set for Wednesday, November 17, 2021. Please remember that all abutter notices for administrative decisions must be sent and the site notices (signs) must be posted at least 10 days prior to the hearing date. These notifications are your responsibility and the lack of proper notification will cause the public hearing date to be postponed. It is important that you obtain an updated list of adjacent property owners from the county before the notices are sent out. Take all necessary steps to ensure an accurate list is obtained. Staff will have the signs available to pick up and will send you the Notice of Pending Administrative Decision via email to send to abutters. Please provide proof of mailing and proof of sign posting to your case manager prior to the decision date.

Note that all our comments are numbered. When you resubmit, include a cover letter specifically responding to each item. The Planning Department reserves the right to reject any resubmissions that fail to address these items. If you have made any other changes to your documents other than those requested, be sure to also specifically list them in your letter.
