Please update the two (2) posted signs with the new hearing date by January 12, 2017. I will send you more information about the hearing as the date approaches.

Please note: City Council may call up the site plan until January 9, 2017. If the site plan is not called up, then the City Council hearing will only involve the requested height waiver.
