Planning Department Comments

1. Aurora Public Schools conducts community outreach independent of the cities process. Though we are glad to hear no comments have been received, community outreach is not required from the city on this project.
2. Completeness and Clarity
 - a. APS believes the COA formatting standards conflict with the MOU between the city and the school district. APS references the Harmony P8 project submissions as being in agreement with the MOU. If the city requires specific information, please let us know, but a submission in the form of Mracheck is not being provided.
