2A. Painted Prairie is responsible for the west half of the Picadilly Road median (including landscaping and irrigation). The median could be deferred if you add a note to the Site Plan and execute a public improvement deferral agreement. Please coordinate with Kristin Tanabe on the language and timing of this deferral.

3. PROS (Michelle Teller / 303-739-7437 / mteller@auroragov.org / Comments in purple)

3A. The note on Sheet 4.03 that states that "separate median landscape and irrigation submittal to PROS required by future roadway applicant concurrent with preparation of Civil Plans" is inconsistent with the approved FDP. Per the FDP, the design and construction should occur with this development. Please coordinate with Public Works if changes are proposed to the timing.
