1.0 PURPOSE

The purpose of this plan is to provide the necessary information for meeting Water Quality requirements as required by the Oil and Gas Operator Agreement between ConocoPhillips Company (COPC), a Delaware corporation, and its subsidiaries, and Burlington Resources Oil & Gas Company LP, a Delaware limited partnership, and the City of Aurora, Colorado, a municipal corporation. This plan addendum is intended to address site specific items. Each location presents unique challenges related to topography, condition of surrounding domestic water wells, orientation of sampling location, aquifer availability and conditions driven by the Operator Agreement.

2.0 SCOPE

Field-wide Groundwater Monitoring Plan addresses requirements in broad terms. Many aspects of the Groundwater Monitoring strategy are common to all locations. This site-specific plan addendum is intended to address only the aspects that are unique to a certain location and will not repeat general terms outlined in the field-wide plan.

3.0 OBJECTIVES

The following objectives are applied to the site-specific addendum.

- Identification of all water wells within ½ mile of the proposed O&G location, as shown in **Figure 1**
- Determination criteria of each water well's sample rank, as show in **Table 1**





Figure 2: Typical Well Construction

- Well construction diagram (to be finalized at a later date), as show in **Figure 2**

Below is a brief summary of APTIMs efforts to identify and document potential sampleable domestic water wells located within ½ mile of the Grande South location.

Initial Phase I Due Diligence efforts were completed, at the direction of ConocoPhillips, in order to identify domestic water wells which could be utilized as sample locations as required by the City of Aurora Operators Agreement (OA). Phase I efforts included a review of all available documentation associated with permitted water wells located within ½ mile of the Grande South location. Of the three (3) downgradient wells identified one is a alluvial stock well and two are domestic water wells. Of the two domestic water wells, field confirmation is recommended prior to committing to sample the two wells as they are likely in a state of disrepair and may be unsuitable for sampling. The remaining water wells identified within ½ mile of the Location are upgradient and are therefore unsuitable for sampling as per the OA.

Due to the lack of confirmed sampleable wells available within ½ mile of the Location, it is recommended that a Form 4 Sundry Notice be prepared for the Grande South location and submitted to meet the requirements of COGCC Rule 609. Following that it is also recommended that a Variance Request be submitted to the City of Aurora to meet the requirements of the Operators Agreement.

The water wells which APTIM identified as being located within 1/2 mile of the Grande South location and their associated sample designations are listed below.
