- 3E. The Site Plan will not be approved until the preliminary drainage letter/report is approved.

- 3G. All proposed corridors including drainage, utility and access need to be shown on the site plan.
- 3H. Items that are referenced to the civil plans need to be included on the site plan.
- 3I. Indicate the maximum height or height range for all walls. Walls greater than 30" require a railing or barrier.

##### *Sheet AC1.2*

- 3J. Is the ROW shown the ultimate ROW? Dimension the existing and future ROW.
- 3K. Include typical sections with the Site Plan.

##### *Sheet AC1.12*

- 3L. See comment 3M above regarding heights for walls.
