- Beacon Point meets and exceeds the minimum required open space per the FDP, annexation agreement, and metro district. At this time, the roads, the elementary school, and the land within the 500' Buffer are the only intended dedications to the City of Aurora. All other open space will be privately owned and maintained by the HOA or the Metro District. Please refer to the Open Space Credit and Distribution charts below.
- All proposed arterial and collector streets will be in accordance with City of Aurora Street Standards.
- Please refer to the Metro District Design Guidelines for the intended uses in the NACs and Neighborhood Parks.

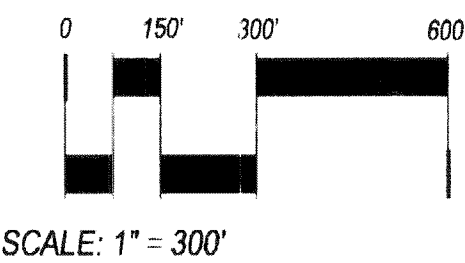
