Mr. Brungardt,

Thank you for your correspondence concerning our East Bend project. We received an email from The City of Aurora with your concerns and below are the responses to your questions and concerns.

1. Concerns with narrowing a street that has people exceeding the speed limit at all hours and a school bus stop.

Response: The street width will be increased slightly from 24' to 34' from curb to curb. The intent of the street vacation is to narrow the limit or boundary of the street and add more area for landscape next to the street. We are also installing curb, gutter, and a detached 5' sidewalk along the west side of South Andes Circle.

2. Are there plans for a speed bump?

Response: The city and a traffic study for the project determined there is no speed bumps needed.

3. Also, taller/new fences to block out the extra traffic from the development? Is the Walking path going to move closer to the owners fence during this project?

Response: Our project will not impact the east side of South Andes Circle, so no changes will be made to the fences or sidewalk along that portion of the road.

4. Any plans for a stop light on the northwest side of Andes circle there has been multiple accidents on this corner as there is no merge lane.

Response: Yes, the City will be installing a traffic signal at the north intersection of Tower Road and South Andes Circle. We will contribute a portion of the cost and dedicate land for the traffic signal location.
