## Technical Corrections Review

- 1A. Make minor revision on the Cover Sheet per redline comments.
- 1B. Please note that a digital submission meeting the <u>CAD Data Submittal Standards</u> is required before the final Infrastructure Site Plan mylars can be routed for signatures or recorded. Please review the CAD Data Submittal Standards and email the .DWG file to your Case Manager before submitting your final mylars.
- 2. Landscaping Issues (Kelly Bish / 303-739-7189 / kbish@auroragov.org / Comments in bright teal)
- 2A. Revise the plant material within portions of the sight distance triangles as it will get taller than 26" as measured from the roadway surface. See redline comments.
- 2B. The pen settings or colors of the plan material were changed between this submittal and the previous one. The plant material is too dark, especially when printed out. The shrub beds appear as black blobs. Please fix this before the next submittal.
- 2C. No storm line is shown where indicated on Sheet 10.
- 3. Civil Engineering (Kristin Tanabe / 303-739-7306 / ktanabe@auroragov.org / Comments in green)
- 3A. The ISP will not be approved by Public Works until the Preliminary Drainage Report is approved.
- 3B. Add "with railing" to the retaining wall detail on Sheet 4.
- 3C. Concentrated flows should not be directed across the maintenance access paths.
- **4. Aurora Water** (Casey Ballard / 303-739-7382 / cballard@auroragov.org / Comments in red)
- 4A. By changing the area on Sheet 6 to a swale, is the existing access path going to be compromised? Any concentrated flows across an access path require a culvert sized to allow the flows to pass underneath the path.
- 5. Real Property (Maurice Brooks / 303-739-7294 / mbrooks@auroragov.org / Comments in magenta)
- 5A. There are several items that need to be dedicated by separate document. Contact Andy Niquette to begin the process. This must be complete prior to the ISP being recorded.
