- 7H. The grading plan needs to include the entire site, not just the area of improvement.
- 7I. Please label the existing and proposed easements on site.
- 7J. An access easement is required from the drainage easement to the public right-of-way. Please coordinate this easement dedication with the Real Property Division.
- 7K. Show and label the pond maintenance access. Access is required to the bottom of the pond and the top of the outlet structure.
